The following question have been received. The County's answer follows in **bold**.

- Are there hardware sets available for this project? There are remarks regarding alarms and delayed egress under door schedule remarks but there is no remark number on the door schedule.
 Remarks shown on plans does not apply.
- 2. What is the wall panels type and thickness for building? The Project building will be design and stamped by the Metal Building designer. As long as it meets the wind requirement per ITB 24-37 and Scope of Work.
- 3. What type of roof panels and thickness for building? **Designer** decision as long as it meet requirement set forth in ITB 24-37 and scope of work.
- 4. What frame type is requested for this building? **Designer decision** as long as it meet requirement set forth in ITB 24-37 and scope of work.
- 5. Any specific color for the roof or wall panels? White.
- 6. Any specific warranty to be included as part of the building? **Stand** metal building warranty per the selected brand by bidder.
- 7. What is the insulation R-Value of Roof and Wall? **Meet Code.**
