The 117th exclusively utilizes KMC for HVAC system's Direct Digital Controls. This is the only manufacturer that is utilized to allow for standardization and guaranteed interoperability. To build a structure that did not utilize this system would compromise the ability to control and monitor base utilities to reduce energy consumption to the maximum extent possible. Utilizing other manufacturers would necessitate the purchase of additional centralized monitoring systems for the Security and Services Training Facility B209 and Civil Engineering B700.

**Efforts to Obtain Competition:** A pre-solicitation notice was placed in sam.gov in order to give contractors an early notification of this project.

**Market Research:** There are many manufacturers of DDC controls, but the 117<sup>th</sup> ARW uses KMC controls basewide. In order to change control systems the whole base would need to be converted to the new brand and that is not currently economically feasible. A project is in the planning stage to convert the DDC system to a non-proprietary system allowing different vendor DDC controls to be managed by one central system. This project is in its infancy and will not affect the need to use KMC controls for this project.

**Facts:** The KMC DDC system is the only manufacturer that is compatible with the current HVAC control system.

**Reason for Authority Cited:** Stanley Best Access Systems-Locks: Master-keyed interchangeable lock cores manufactured by Stanley Best Access Systems are the standard for securing buildings at the 117 ARW. Lock handles and other devices aren't required to be Stanley Best Access Systems, but all other devices must be fully compatible with MX-8 Best Access cores. Without Stanley Best Access System-Locks, the integrity of the security for the 117th ARW would be compromised.

**Efforts to Obtain Competition:** A pre-solicitation notice was placed in sam.gov in order to give contractors an early notification of this project.

**Market Research:** The Stanley Security patent ensures that MX8 keys can only be manufactured by Stanley, and Stanley will only sell MX8 keys to end user customers after verifying that the individual is an authorized purchaser. The MX8 patented keying system helps limit key duplication, while giving facility access to the users. Lock handles and other devices aren't required to be Stanley Best Access Systems but must be fully compatible with MX-8 Best Access cores.

**Facts:** The Stanley Best Access System-Locks MX-8 cores are the only lock cores that are compatible with the key cuttings security system maintained by the Base Real Property Manager.
