3. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

This contract action is to award a firm-fixed price contract for construction of the Mission Training Center Facility located on Joint Base San Antonio (JBSA), Lackland Air Force Base (AFB), Kelly Field, 149 Fighter Wing (149 FW). The Brand Name requirements in support of this project is a Direct Digital Control (DDC) System: Automated Logic Corporation WebCTRL Building Automation System.

4. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The existing base wide control system is WebCTRL from Automated Logic Corporation. Currently there's an approved Authority to Operate (ATO) to use this system for Joint Base San Antonio. The new EMCS system will allow 149 FW a precise and centralized control and monitoring over building systems such as HVAC and lighting. HVAC outages in South Texas heat are emergencies and this system monitors and alerts technicians of outages. Additionally, this system tracks
