3. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

This contract action is to award a firm-fixed price contract for construction of the Mission Training Center Facility located on Joint Base San Antonio (JBSA), Lackland Air Force Base (AFB), Kelly Field, 149 Fighter Wing (149 FW). The Brand Name requirements in support of this project are for Fire alarm control panels: Monaco MAAP-X.

4. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The current fire alarm reporting system used by JBSA Lackland AFB fire station is the Monaco radio transceiver system. The base standard for fire control panels is specified as a Monaco system. Monaco Enterprises, Inc. is the only company that provides the Factory Mutual Certified fire alarm/ mass notification equipment that is currently installed on JBSA Lackland. This system is primarily comprised of proprietary codes developed by Monaco Enterprises, Inc. (MEI) that are licensed directly to the end users. MEI retains exclusive ownership of these codes and does not license to third parties to alter or add to their software or equipment.

5. MARKET RESEARCH:

Monaco Enterprises, Inc. is the only company that provides the Factory Mutual Certified fire alarm/ mass notification equipment that is currently installed on JBSA Lackland. This system is primarily comprised of proprietary codes developed by Monaco Enterprises, Inc. (MEI) that are licensed directly to the end users. MEI retains exclusive ownership of these codes and does not license to third parties to alter or add to their software or equipment.

Currently the base uses fire alarm control panels: Monaco MAAP-X. When a new system is required in the future, market research should be accomplished to determine if there are any compatible fire alarm control panels with interoperability across multiple brands.
