3. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

This contract action is to award a firm-fixed price contract for construction of the Mission Training Center Facility located on Joint Base San Antonio (JBSA), Lackland Air Force Base (AFB), Kelly Field, 149 Fighter Wing (149 FW). The Brand Name requirements in support of this project are an Intrusion Detection System: Honeywell Vindicator Electronic System.

4. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The Vindicator System will provide both an Intrusion Detection System (IDS) and an integrated Access Control System (ACS).

Intrusion Detection System: Honeywell Vindicator Electronic System: There are only 3 alarm system vendors approved

5. MARKET RESEARCH:

There are only 3 alarm system vendors approved by the Air Force in accordance with A7SSecurity System Project Description (SSPD): Diebold, Advantora, or Vindicator. Installation shall be guided by security doctrines contained within AFI 31-101 and AFI 31-401. Only Vindicator systems are currently installed at JBSA Lackland, therefore, this brand has been chosen as the most economical path for base-wide standardization from the 3 brands approved by the SSPD.

6. PROVIDE A STATEMENT OF ACTIONS, IF ANY, THE GOVERNMENT MAY TAKE TO REMOVE OR OVERCOME ANY BARRIERS TO COMPETITION BEFORE FUTURE ACQUISITIONS ARE REQUIRED:

Currently the base uses an Intrusion Detection System: Honeywell Vindicator Electronic System. When a new system is required in the future, market research should be accomplished to determine if there are any compatible Intrusion Detection System with interoperability across multiple brands.
