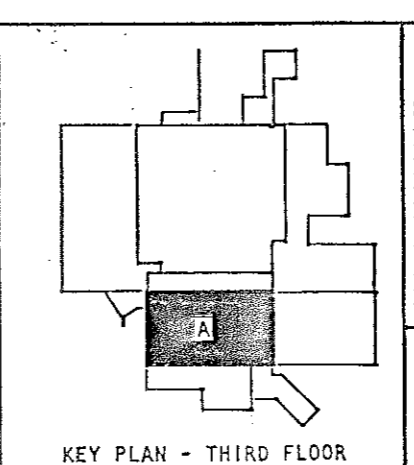
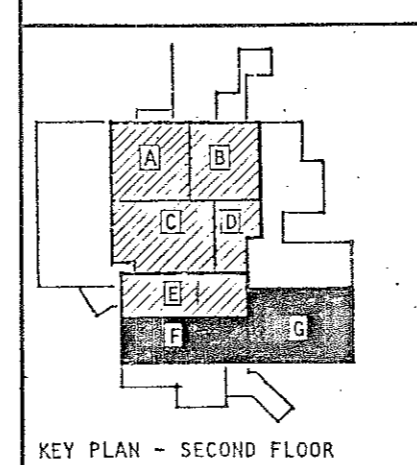


COMPOSITE SECOND FLOOR PLAN
