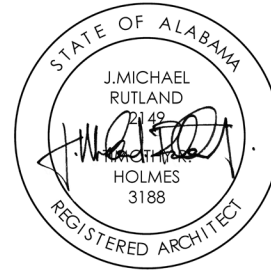

ADDENDUM NO. 2

Autauga WMA Office Meeting Complex
Prattville, Alabama



This Addendum No. 2, to the plans and specifications, dated 02 December 2025, consists of Four (4) Pages.

Item No. 1: Refer to the Project Manual.

- A. **CLARIFICATION:** A sewer Permit will be obtained by the Owner.

Item No. 2: Refer to Specifications, Section 13 34 19 "Metal Building Systems":

- A. **CLARIFICATION:** Interior and Exterior Vertical Metal Wall Panels are to be provided by the Pre-Engineered Metal building Manufacturer per Specification section 13 34 19 "Metal Building Systems"

Item No. 3: Refer to Plans, Sheet L1.1, 9 of 46, Landscape Plan:

- B. **CLARIFICATION:** Red Buckeye Trees are acceptable at a height of 6' – 7'.
C. **CLARIFICATION:** Irrigation is required and a performance spec has been included in the Project Manual. Refer to Specification Section 32 84 23 "Underground Sprinklers"

Item No. 4: Refer to Plans, Sheet A2.1, 17 of 46, Large Scale Plans and Elevations:

- A. Refer to Specification Section 06 41 00 "Interior Architectural Woodwork" Section 2.05 E for solid wood cabinet requirements.
B. **CLARIFICATION:** All Shaw Contract 5 mm 20 mil LVT is the same price.
C. **CLARIFICATION:** Men 102 and Women 120 Ceiling heights are 10'-0"
D. **CLARIFICATION:** Storage 109 walls shall be SS-1 /MP-1 / and GWB-1. Disregard P-1 currently listed in the finish schedule.
E. **CLARIFICATION:** Metal trim units shall be used at base, external corners, and edges.

Item No. 5: Refer to Plans, Sheet A4.1, 20 of 46, Exterior Elevations:

- A. **CLARIFICATION:** All water tables and column caps shall be Synthetic Cast Stone. Refer to specification section 04 72 00 Cast Stone Masonry.
B. **CLARIFICATION:** Refer to Sheet A1.4 for sizes and details of cast stone column caps.

Item No. 6: Refer to Plans, Sheet P1.1 and P3.1, 35 of 46 and 37 of 46, Plumbing Non-Pressure Plan and Plumbing Isometrics:

- A. See attached Revised plumbing sheets P1.1 and P3.1 for revised 4" drain line.

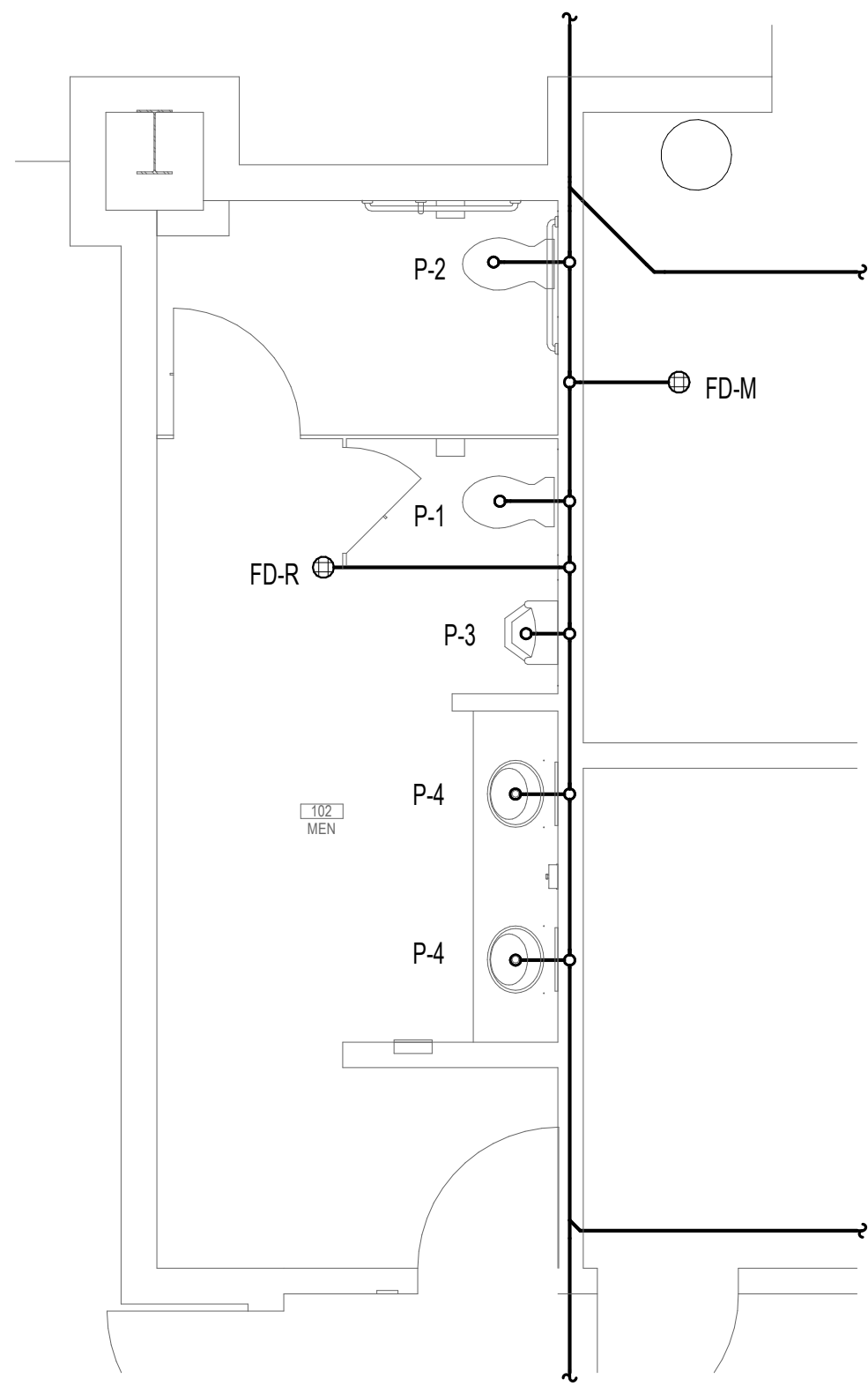
Item No. 7: The following manufacturers / products are approved subject to compliance with contract documents:

- A. 13 34 19 Metal Building Systems – Vulcan Steel Structures is hereby approved subject to strict conformance with the plans and specifications.
B. 13 34 19 Metal Building Systems – Pinnacle Structures is afforded prior approval subject to strict conformance with the contract documents.
C. 13 34 19 Metal Building Systems – Inland Buildings is afforded prior approval subject to strict conformance with the contract documents.

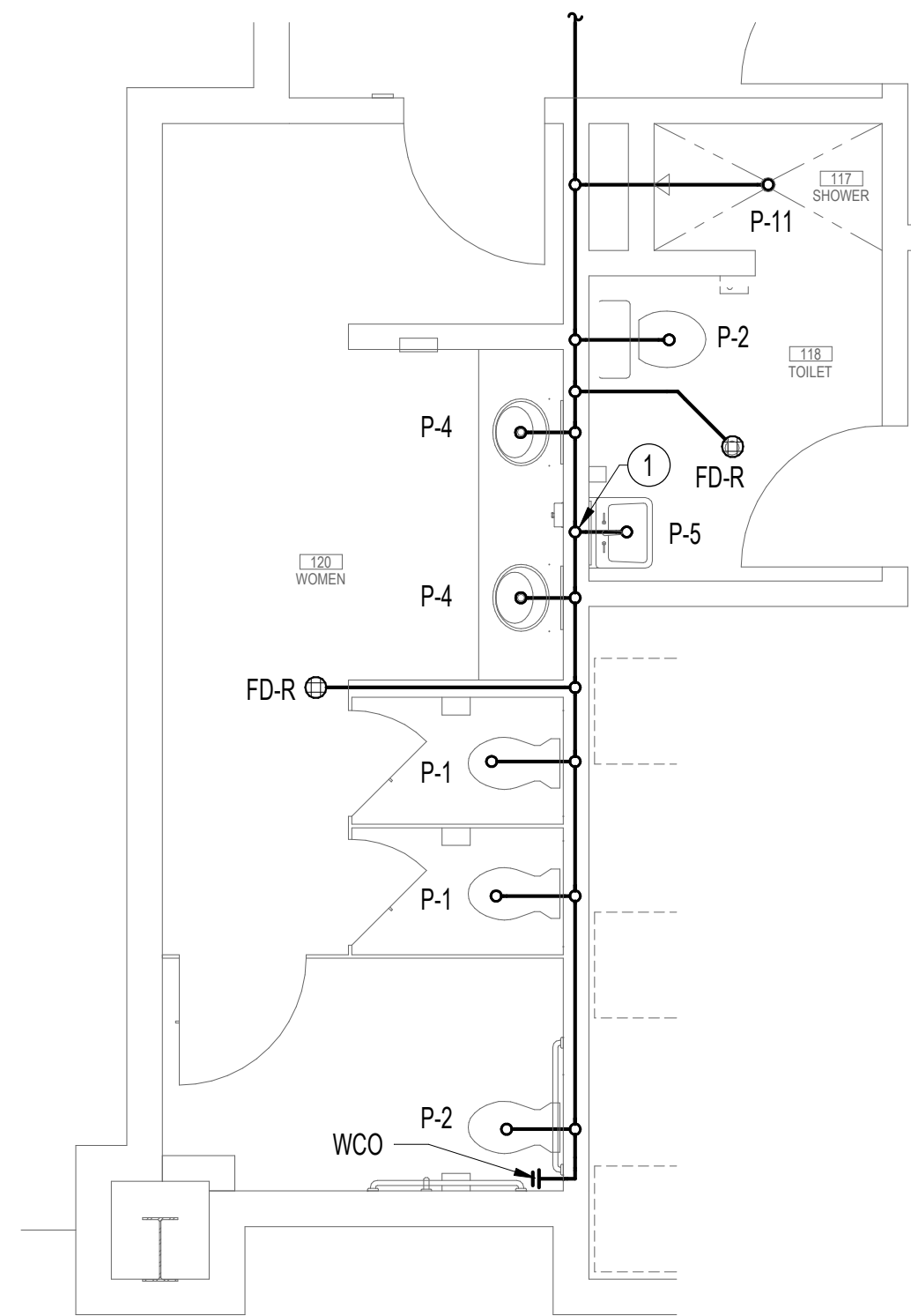
- D. 13 34 19 Metal Building Systems – Bigbee Steel Buildings is afforded prior approval subject to strict conformance with the contract documents.

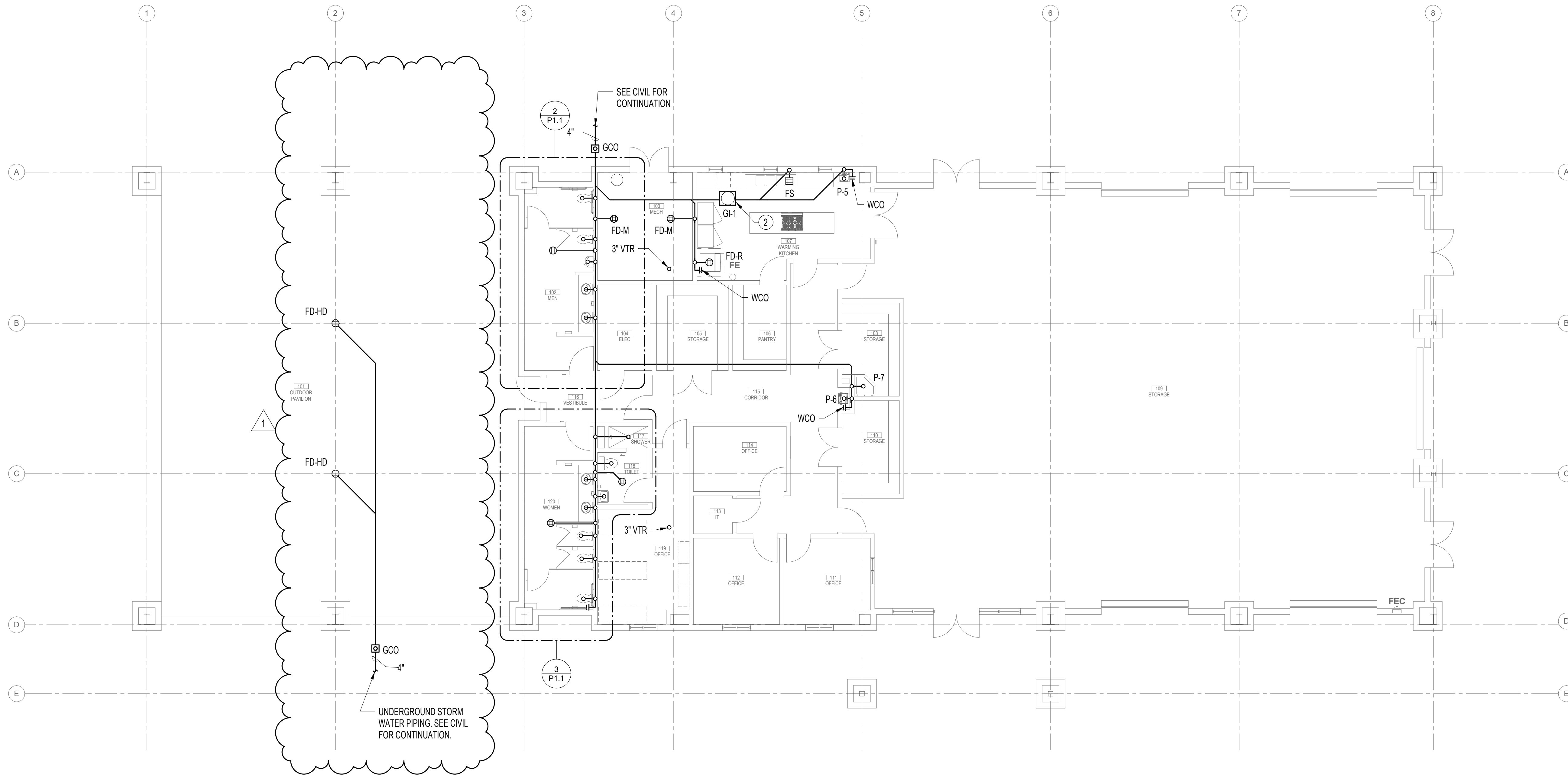

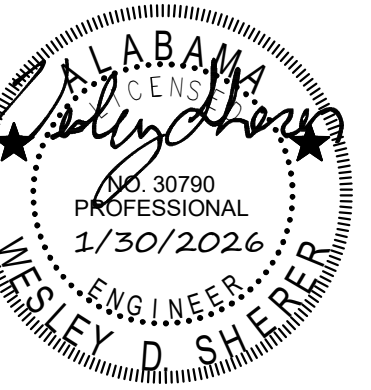

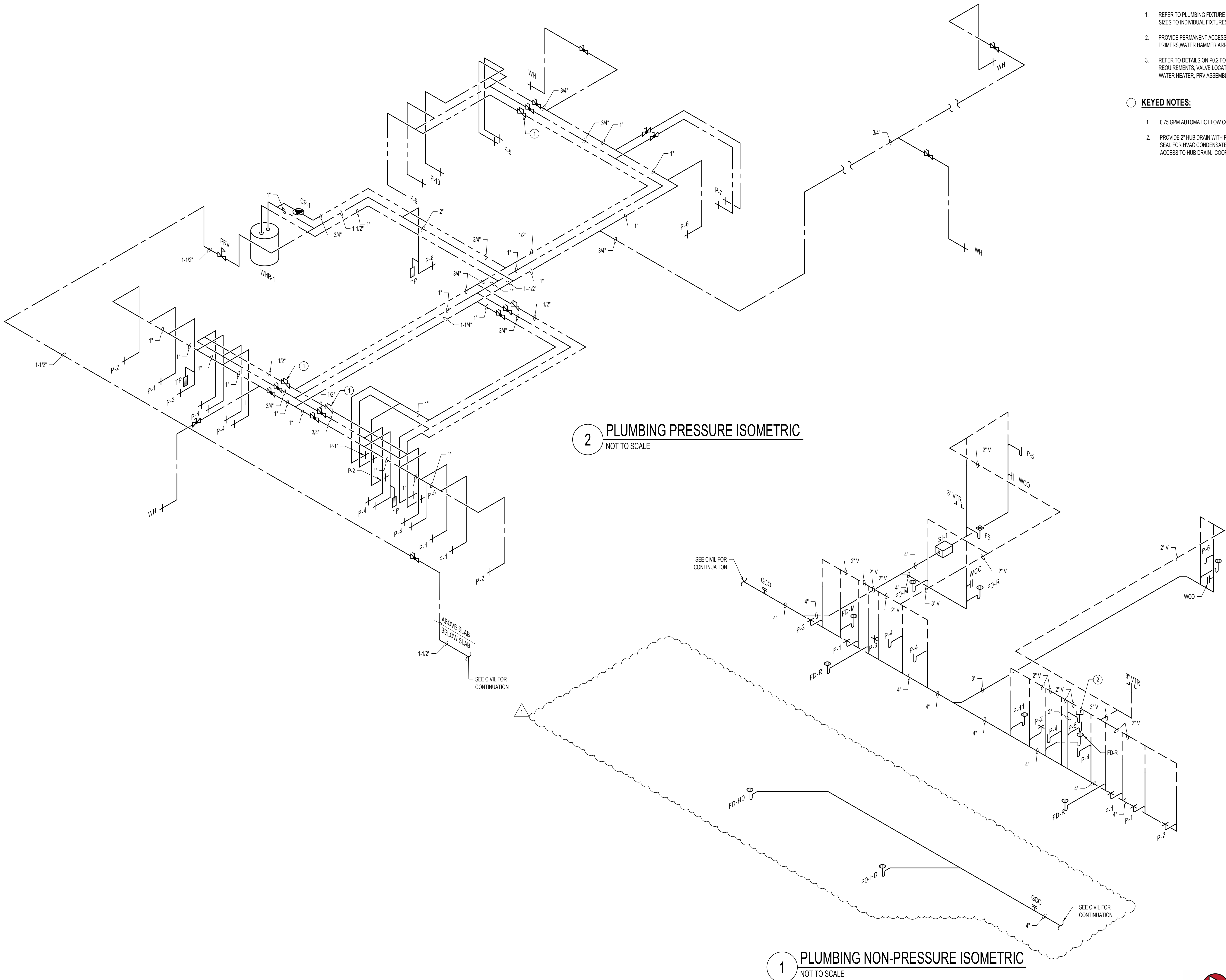
